CONDITIONS OF SERVICE

Salem Electric will furnish, install, operate, and maintain the lighting installation at a mutually agreeable location. Individual lamps will be replaced on burnout, as soon as reasonably possible after notification by the consumer, during the normal work week, and at no additional charge to the consumer.

If a pole other than an existing pole is required, Salem Electric will install such pole and the monthly rate per pole shall be:

Wood Pole (01) \$1.75; Steel Pole (04) \$7.45; Ornamental Pole (03) \$3.35

The complete lighting installation shall remain the property of Salem Electric. The consumer will protect the lighting equipment from deliberate damage. The consumer must allow Salem Electric free access to maintain and inspect the equipment.

MINIMUM CHARGES

The minimum monthly charge will be the applicable monthly charge for the installation.

CONTRACT REQUIREMENTS

Property owners must sign a lighting contract, but the charges may be billed to tenants. Consumers under this rate will be required to execute a contract for a minimum term sufficient to allow Salem Electric to recover the cost of investment.
